ACP WAS TRAVELING SOUTH ON US#1, APPROXIMATELY 7 MILES NORTH OF MCBEE, SC, AT 12:30 A.M., ON JULY 25, 1999. THERE HAD BEEN A LARGE RAINSTORM JUST PRIOR TO THIS TIME. APC DRIVER TURNED ONTO WIDOW JOHNSON ROAD OFF OF US #1 (WHICH WAS A DIRT ROAD). AS DRIVER CRESTED A HILL AND STARTED DOWN A LONG DOWNHILL GRADE, THE APC UNIT BEGAN TO SLIDE INTO THE RIGHT SIDE DITCH BECAUSE OF THE MUD. AFTER UNIT TRAVELED A SHORT DISTANCE, DRIVER MADE EFFORT TO PULL UNIT BACK INTO ROADWAY AT WHICH TIME UNIT OVERTURN ON ITS RIGHT SIDE. APPROXIMATELY 3,740 GALLONS OF PRODUCT WAS SPILLED.
