Describe:

According to the information obtained, the following occurred. While traveling, single-vehicle accident resulted in a rollover, which damaged the cargo tank. Cargo tank contained approximately 8,329 gallons of alcohols, nos. Milton Fire Department and Wisconsin Department of Natural Resources responded to assess the site. Highway 59 was shut down in both directions. Per direction from Milton Fire Department and Wisconsin Department of Natural Resources on site, product was released to a nearby retention pond, to prevent threat to human health and the environment. Groundwater sampling and periodic site monitoring was performed to ensure safety and confirm no potential hazards remain. There were no injuries or exposures reported.
