TANK TRAILER WAS IN POSITION AT LOADING RACK AND DURING THE LOADING OF SAME-PRIOR TO DEPARTURE, A LEAK WAS DISCOVERED AT THE SUMP AREA ON THE BOTTOM OF THE TANK TRAILER. THE PRODUCT WAS RUNNING OUT AT A STEADY RATE AND DECISION WAS MADE TO LET TRAILER STAY IN PLACE AND RECOVER ALL OF THE PRODUCT INTO SHIPPER'S CONTAINMENT SYSTEM. NOTE [1]NO PRODUCT ESCAPED INTO SOIL, WATERWAYS, OR ATMOSPHERE; THEREFORE, NO REPORT WAS MADE TO NRC BY CARRIER. [2] REPORT IS LATER THAN THE 30 DAY REQUIREMENT.
