THE PLANT OPERATOR GAVE THE CTL DRIVER AUTHORIZATION TO OPEN THE TRAILER VALVES. AFTER THE CTL DRIVER OPENED HIS TRAILER VALVES THE PLANT OPERATOR PROCEEDED TO OPEN THE CUSTOMERS VALVE. THE PLANT OPERATOR OPENED THE WRONG VALVE AND UNLOADED APPROX. 200 GALLON OF PRODUCT INTO THE PLANTS CONTAINMENT AREA. THE PLANT OPERATOR TOOK FULL RESPONSIBILITY FOR THE SPILL AND THE PLANT PERFORMED THE PROPER CLEAN UP.
