OUR DRIVER HAD LOADED A ROLL OFF BOX WITH ELECTRIC ARC FURNACE DUST. THIS WASTE MATERIAL IS LIKE TALCUM POWDER AND FLOWS VERY EASY. ONCE THE ROLL OFF WAS LOADED AND TARPED, THE DRIVER TOOK OFF WITH IT. WHEN HE HAD TO BRAKE HARD, THE MATERIAL FLOWED FORWARD, UP UNDER THE TARP AND OUT ONTO ROAD AND FRAME OF TRAILER. OUR DRIVER WAS UNAWARE OF THE SPILL AND CONTINUED WITH SMALL AMOUNTS BLOWING OFF OF TRAILER. THE MATERIAL WAS CLEANED UP BY THE GENERATOR WHO HAD SEEN THE MATERIAL ON THE ROAD. WE ARE NO LONGER USING ROLL OFF BOXES W/O HARD TOPS.
