TRAIN Q30207 STRUCK THE REAR OF TRAIN V60105 RESULTING IN THE DEATH OF THE ENGINEER ON Q302 AND DERAILING 4 COAL HOPPERS IN V601, 2 LOCOMOTIVES AND 15 CARS Q302. FIVE HAZMAT CARS WERE DERAILED; 1) A LOAD OF AMMONIA NITRATE, 2) A LOAD OF SODIUM HYDROXIDE, 3) A RESIDUE HYDROGEN PEROXIDE, 4) A LOAD OF SULFURIC ACID,, 5) A LOAD OF ACETALDEHYDE. THE ACETALDEHYDE CAR (ETCX 29087) WAS PUNCTURED WITH A COUPLER ON THE A END. THE RELEASE PRODUCT CAUGHT FIRE & BURNED FOR SEVERAL HOURS. ABOUT 200 PEOPLE WERE EVACUATED INITIALLY. ALL BUT 5 FAMILIES WERE PERMITTED TO RETURN HOME ON 7/8. LOCAL STATE & FEDERAL AGENCIES RESPONDED. THE SULFURIC ACID WAS TRANSLOADED FROM SAZX 21600 TO SAZX 21464. APPROXIMATELY 19000 GALLS OF ACETALDEHYDE WAS CONSUMED IN THE FIRE. THE SODIUM HYDROXIDE AND AMMONIUM NITRATE CARS WERE RERAILED WITHOUT DIFFICULTY.
