Describe:

On July 12, 2024, one (1) 330-gallon tote of sodium hydroxide was damaged by a load shift and released approximately 300-gallons of product to the trailer interior and concrete below. R+L Carriers retained Cura Emergency Services, LC who dispatched a crew from First Call Environmental (FCE) to remediate the impacted site. FCE crews utilized neutralizer throughout the trailer and on the concrete below, then deployed granular absorbents to the trailer and concrete, working them in with hand tools. utilized a forklift to transfer the remaining contents in the damaged tote into new one. All sodium hydroxide-impacted material was collected and containerized in four (4) 55-gallon drums
