AT ABOUT 11:00 AM ON OCTOBER 22,1992 A LAROCHE DRIVER HAD JUST COMPLETED DELIVERY OF ANHYDROUS AMMONIA INTO A SPECTRA PHYSICS STORAGE TANK. AS THE LAROCHE DRIVER SHUT DOWN THE AMMONIA TRANSFER PUMP, THE PUMP SHAFT FAILED AND AMMONIA PRODUCT BEGAN DISCHARGING THROUGH A 1/8" WEEP HOLE AND FROM AROUND THE SHAFT SEAL. THE FISHER INTERNAL VALVE ALSO FAILED TO SEAT PROPERLY. LAROCHE EFFORTS, AS WELL AS THE EFFORTS OF EMERGENCY RESPONDERS FAILED TO CLOSE THE INTERNAL SAFETY VALVE. ABOUT 700 LBS OF AMMONIA WAS DISCHARGED TO THE ENVIRONMENT OVER 8 HOURS.
