THE SPILL WAS CONTAINED IN THE DITCH. LIMESTONE WAS USED TO NEUTRALIZE THE SPILL. APPROX. 220 YARDS OF CLEANUP (POLLUTION CONTROL WASTE) WAS SHIPPED TO APPROVED DISPOSAL FACILITY (SEE ATTACHED). ALL AFFECTED AREAS WERE TESTED AND CLEARED.
