US FUEL OIL TRUCK WAS TRAVELING NORTH ON RT 295 AT A SPEED OF 50 MPH. THE RIGHT FRONT SPRING BROKE CAUSING THE TRUCK TO ROLLOVER. THE TRUCK STRUCK APPROX. 250 YARDS OF GUARD RAIL AND THEN ROLLED DOWN AN INCLINE IMPACTING A LARGE ROCK CAUSING THE REAR BULKHEAD TO RUPTURE. FIRE AND RESCUE UNITS WERE IMMEDIATELY DISPATCHED TO THE AREA AS WELL AS A CLEANUP CREW WHICH CONTAINED THE SPILL. THE BALANCE OF THE FUEL LEFT ON THE DAMAGED VEHICLE WAS OFFLOADED INTO US FUEL TRUCKS. WHEN EMPTIED, A WRECKER WAS BROUGHT IN TO REMOVE THE TRUCK FROM THE SCENE.
