TRANSFERRING FERRIC CHLORIDE SOLUTION FROM TANK CAR TO MC312 LINED CARGO TANK BY ATTACHING A PVC FLANGED FITTING WITH BALL VALVE TO THE UNLOADING PIPE ADAPTOR ON THE TANK CAR. CARGO HOSE WAS ATTACHED BY FOUR-BOLT FLANGE TO THE PVC COMPONENTS BOLTED TO UNLOADING PIPE ADAPTOR. THE OTHER END OF CARGO HOSE AS ATTACHED TO FILTRATION SYSTEM INLET. A CARGO HOSE FROM CARGO TANK WAS ATTACHED TO FILTRATION SYSTEM OUTLET. APPROXIMATELY 22 PSIG. AIR PRESSURE FROM A COMPRESSOR WAS APPLIED TO THE TANK CAR AND PRODUCT TRANSFERRED TO THE CARGO TANK. DURING THIS TRANSFER, THE PVC FLANGE BOLTED TO THE UNLOADING PIPE ADAPTOR FAILED. PRODUCT RELEASED FROM TANK CAR UNLOADING PIPE ADAPTOR, SPRAYING INTO THE AIR AND ONTO THE ADJACENT GROUND. BULK TRANSPORTATION PERSONNEL EVACUATED THE AREA AND MADE TO NOTIFICATION TO CLARK COUNTY FIRE DEPARTMENT AND BULK TRANSPORTATION. FIRE DEPARTMENT ISOLATED THE AREA AND ALLOWED THE TANK CAR TO RELEASE ALL ITS PRESSURE. AN ENVIRONMENTAL CLEANUP COMPANY WAS CALLED IN TO CLEAN UP AND REMOVE CONTAMINATED SOIL. BULK TRANSPORTATION HAS DISCONTINUED THE USE OF PVC OR OTHER NON-METALLIC VALVES AND FITTINGS ON TANK CAR TRANSFERS. IN ADDITION, WE ARE USING AUTOMATIC SELF-CLOSING VALVES ON PRODUCT TRANSFERS TO SHUT DOWN PRODUCT FLOW IN AN EMERGENCY.
