TRACTOR PULLING SEMI TRAILER (TANK) AND A PUP TRAILER LOADED WITH MOLTEN SULFUR. PULLED OUT OF LOADING AREA AND PROCEEDED UP ACCESS ROAD TO A LEFT TURN, CROSSING A RAILROAD SPUR. DRIVER CHECKED BACK AT PUP THROUGH MIRROR TAKING HIS EYES OFF THE ROAD. THE TRACTOR STEERED TO THE RIGHT UNTIL THE RIGHT FRONT STEERING TIRE DROPPED OFF THE PACKED PORTION OF THE ROAD INTO SOFT DIRT AND THEN INTO SNOW. WHEN THE DRIVER SAW HIS MISTAKE IT WAS TOO LATE TO CORRECT. THE ENTIRE UNIT ROLLED OVER AND SLID DOWN A HILL IN DEEP SNOW. BECAUSE OF THE ANGLE AND LOCATION OF THE WRECKAGE, THE CARGO HATCHES WERE OPENED AND THE CARGO WAS ALLOWED TO RUN OUT INTO A BASIN AREA WHERE IT WILL BE RECOVERED AND PLACED IN A LAND FILL.
