Describe:

Driver was unloading into a diesel tank at a remote fill connection. The connection was identified as a diesel tank. The fill cover/cap located on the UST was not properly secured. The tank overfilled and the product was released from the remote fill point. All product was contained on the concrete and was catch basin. No product impacted the soil or water.

Our investigation determined that the facility failed to identify the tank as being out-of-service and failed to have proper tight fill cap secured on tank. Even though the tank was out-of-service, the facility maintained the tank full with diesel.
