THE MEDFORD HAZMAT RESPONSE AGENCY NOTIFIED OUR MEDFORD OFFICE THAT A TANK CAR ON OUR TRAIN IN MEDFORD WAS LEAKING. UPON INSPECTION BY OUR SUPT. OF OPERATIONS, THE CAR WAS DETERMINED TO BE LEAKING FROM ITS BOTTOM OUTLET VALVE GASKET AT A RATE OF APPROX. 1 GAL/MIN. THE CAR WAS THEN SET OUT OF THE TRAIN IN OUR MEDFORD RAIL YARD AND ISOLATED, PENDING ARRIVAL OF THE OREGON EMERGENCY RESPONSE TEAM AND MEDFORD FIRE DEPT. AT APPROX. 0945 THESE TWO AGENCIES WERE ABLE TO TIGHTEN THE VALVE SO THAT THE LEAK WAS REDUCED TO ABOUT 1 GAL/HR., AND A 5 GAL BUCKET WAS ATTACHED TO THE BOTTOM OF THE CAR TO CATCH THE SPILL. THE MEDFORD FIRE DEPT. THEN GAVE PERMISSION FOR THE RAILROAD TO MOVE THE CAR TO GEORGIA PACIFIC AT WHITE CITY (APPROX. 13 MILES) FOR UNLOADING.
