Describe:

Employee pumped material from cargo tanker into wrong sized ethanol storage tank. There was not enough room in tank to hold all material. 1077 gallons ran out the top vent of the storage tank spilling into the tank containment area. Spill was not noticed until approximately 2 hours afterward during a tank reading. Material was all contained but evaporated prior to discovery.

Retrained employee on procedure to follow when unloading material from cargo tank motor vehicle to storage tank. Required double checks on tank selection and identification were stressed. Tanks have now been marked on sides and tops to assist employees to verify they have selected the correct sized tank. They then can verify there is adequate space to hold the material intended to fill into the tank.
