THIS SPILL WAS RESULT OF SINGLE VEHICLE ROLLOVER ACCIDENT IN WHICH THE DRIVER OF OUR TRUCK WAS THROWN CLEAR OF THE TRACTOR DURING THE ROLLOVER PROCESS, AND WAS FOUND DEAD AT SCENE FROM CAUSES (UNKNOWN AT DATE OF THIS REPORT) BUT NOT AS A RESULT OF CONTACT WITH THE CONTENTS OF TANK TRAILER. WITNESSES FOLLOWING OUR TRUCK SAW THE VEHICLE SUDDENLY VEER RIGHT AND LEAVE THE HIGHWAY AND ROLLOVER SEVERAL TIMES. WHEN VEHICLE CAME TO REST, TRACTOR WAS DESTROYED, AND TRAILER SUSTAINED HEAVY DAMAGE AND COULD BE SEEN LEAKING FROM AIR VALVES ON TOP. FRESNO COUNTY CALLED IN "M & P" ENVIRONMENTAL SERVICES, INC TO STOP LEAK AND CLEANUP. PRODUCT REMAINING IN WRECKED TANKER WAS TRANSFERRED INTO ANOTHER TANK TRUCK. THAT PRODUCT WAS RETURNED TO SHIPPER. THE PRODUCT WHICH HAD LEAKED INTO SOIL WAS DETERMINED BY CALIFORNIA ENVIRONMENTAL HEALTH SYSTEM OFFICER TO BE VOLATILE ENOUGH TO BE ALLOWED TO EVAPORATE AT THE SITE WITHOUT SOIL REMOVAL.
