ON THE MORNING OF MAY 31, 2000 AT APPROXIMATELY 5:32 AM A RODMAN TRANSPORTATION SERVICE TRUCK WAS TRAVELING SOUTH ON SH121. AS THE TRUCK APPROACHED THE INTERSECTION OF FM423 IN THE COLONY, TX. A BLACK FORD RANGER PICK-UP WAS IN THE RIGHT TURN LANE WITH BLINKER ON TO TURN RIGHT ON FR423. THE PICK-UP TRUCK THEN TURNED LEFT INTO THE LANE OF TRAVEL OF THE RODMAN SERVICE TRUCK. THE DRIVER OF THE SERVICE TRUCK STEERED LEFT TO AVOID THE PICK-UP. THE SERVICE TRUCK BEGAN TO SLIDE AND WHEN THE RIGHT. FRONT TIRE OF THE REAR TANDEM BLEW OUT, THE SERVICE TRUCK OVERTURNED. THE BLACK FORD PICK-UP WAS NOT INVOLVED AND LEFT THE SCENE. APPROXIMATELY 2400 GALLON OF DIESEL FUEL WAS SPILLED ONTO THE ROAD SURFACE AND GRASSY AREAS ON BOTH SIDES OF THE ROAD. A HAZ-MAT CLEANUP COMPANY (DISPOSAL SERVICES) WAS CALLED AND THE AREA WAS EVACUATED. THE TEXAS NATURAL RESOURCES CONSERVATION COMMISSION WAS CONTACTED AND A REPORT WILL BE FILED WITH THEM. THE TEXAS DEPARTMENT OF TRANSPORTATION WAS NOTIFIED AND HAD ENGINEERING PERSONNEL AT THE SCENE. THE CLEAN-UP WAS PERFORMED WITH APPROVALS OF TNRCC AND TX-DOT. THE DIESEL FUEL REACHED ANY WATER SOURCE OR STORM DRAINS NOR WERE THERE ANY SUCH AREA IN CLOSE PROXIMITY TO THE SPILL
