AT 0635, MARCH 27, 1998, A SEMI TRUCK DROVE INTO THE SIDE OF CANADIAN PACIFIC RAILWAY TRAIN NO. 429-26, DERAILING 13 CARS THAT INCLUDED GATX 10017, A TANK CARLOAD OF FLUOROSILICIC ACID, CORROSIVE MATERIAL, THE TANK CAR ROLLED ONTO ITS TOP DAMAGING 3 OF THE MANWAY COVER BOLTS ALLOWING PRODUCT TO SPILL FROM THE MANWAY INTO A DRAINAGE DITCH. APPROXIMATELY 12,000 GALLONS WERE SPILLED CONTAMINATING THE SURROUNDING WATER AND SOIL. THE DRIVER OF THE SEMI TRUCK WAS KILLED ON IMPACT. THE SEMI DRIVER WAS TRAVELING WESTBOUND ON HIGHWAY 32, DURING FOGGY CONDITIONS AND HE APPARENTLY DID NOT SEE THE TRAIN UNTIL JUST BEFORE IMPACT. SERVICE RESPONSE AND REMEDIATION INC., OUT OF MINNEAPOLIS, MN., WAS CALLED TO THE SCENE BY THE CANADIAN PACIFIC RAILWAY, TO NEUTRALIZE THE ACID AND CLEAN UP THE CONTAMINATED SOILS. CLEAN UP WAS COMPLETED ON APRIL 3, 1998.
