ACCORDING TO THE INFORMATION OBTAINED, THE FOLLOWING OCCURRED. WHILE TRAVELING, A VEHICLE ROLLOVER CAUSED DAMAGE TO THE TANK TRUCK, WHICH RESULTED IN THE LOSS OF APPROXIMATELY 5,000 GALLONS OF JET FUEL. THE FREE PRODUCT RELEASED TO THE ASPHALT ROADWAY, SHOULDER EMBANKMENT, AND SOIL WITHIN THE MEDIAN. REPUBLIC CARRIERS DISPATCHED A RECOVERY TANKER TO PUMP REMAINING FUEL FROM DAMAGED TANK. KIOWA COUNTY SHERIFFS DEPARTMENT AND OKLAHOMA HIGHWAY PATROL RESPONDED TO ASSESS THE SITE. ENVIRONMENTAL REMEDIATION SPECIALISTS WAS DISPATCHED TO PERFORM THE CLEANUP. UPON ARRIVAL ON SITE, FREE LIQUID WAS DETECTED WITHIN THE SOIL EMBANKMENT AND SOIL MEDIAN. ERS UTILIZED A VACUUM TRUCK TO RECOVER FREE PRODUCT FROM AFFECTED AREAS, DEPLOYED ABSORBENT BOOM TO PREVENT MIGRATION, AND ASSISTED IN CLEARING THE ROADWAY. CONTINUOUS FREE PRODUCT RECOVERY AND SOIL EXCAVATION WERE PERFORMED BY ERS UNTIL ALL CONTAMINATION WAS RECOVERED. THERE WAS NO IMPACT TO STATE WATERS AS A RESULT OF THE INCIDENT. THERE WERE NO INJURIES OR EXPOSURES REPORTED. DISPOSAL WAS COORDINATED IN ACCORDANCE WITH LOCAL, STATE, AND FEDERAL REGULATIONS.
