Describe:

CTMV was travelling South on State Highway 7 South of Jasper, Newton County, AR. The driver of the CTMV was negotiating a curve to the left and maneuvered into the north bound land, east side of road and overturned onto driver side. CTMV came to rest in the east side ditch of Highway 7 South. The impact of the rollover caused the measuring chamber of the LCR II Meter to break. Vessel was equipped with a check valve on line from pump/meter to vessel was closed manually to avoid further release of propane. The only release of propane was the product contained in the delivery hose. The duration of the release was approximately 2 hours. There was no damage other than cosmetic to the cargo tank/vessel and it did not leak.
