TOTAL OF FOUR CARS DERAILED, TWO CARS CONTAINING HAZARDOUS MATERIAL. THE DERAILMENT WAS CAUSED BY A BROKEN RAIL. THE LOCAL AUTHORITIES WERE NOTIFIED AS WELL AS CHEMTREC, TENN PSC, FRA. THE BODY OF BOTH TANK CARS WERE NOT DAMAGED. THE ONLY SPILLAGE WAS A VERY SMALL AMOUNT OF LEAKAGE FROM THE DOME OF THE GATX 13082. THE TWO HAZARDOUS TANK CARS WERE THE ONLY CARS OVERTURNED.
