WHILE MAKING A LEFT TURN ONTO PRITCHARD ROAD, A 330 GALLON POLY TANK SLID OFF THE BACK OF A CHEMICAL CLEANING TRAILER. IT LANDED IN THE DIRT ON THE SIDE OF THE ROAD. A VACUUM TRUCK WAS IMMEDIATELY DISPATCHED AND ALL OF THE LIQUID CAUSTIC WAS REMOVED. ENVIRONMENTAL RECOVERY, INC. WAS CONTRACTED TO REMOVE AND DISPOSE OF THE CONTAMINATED SOIL. THE FLORIDA BUREAU OF EMERGENCY RESPONSE COORDINATOR WAS ON SITE AND OVERSAW THE REMEDIATION ACTIVITIES. REPORTS WERE MADE TO THE NATIONAL RESPONSE CENTER (REPORT #367579), DEPT. OF PUBLIC WORKS, REGULATORY AND ENVIRONMENTAL SERVICES, AND BUREAU OF EMERGENCY RESPONSE.
