WHILE TRAVELING SOUTH ON ROUTE 1 IN BRUNSWICK, MAINE AT APPROXIMATELY 55 MPH THE DRIVER HEARD A LOUD NOISE COMING FROM THE BOTTOM OF THE TRUCK. THE DRIVER PULLED THE TRUCK OVER INTO THE BREAKDOWN LANE IMMEDIATELY AND FOUND PRODUCT SPILLING FROM THE BOTTOM OF THE TRUCK. THE DRIVER TRIED TO KEEP THE SPILL CONTAINED WITH SORBENT PADS AND THEN CALLED THE DISPATCHER ON THE COMPANY RADIO FOR HELP. ON CLOSER INSPECTION THE DRIVER FOUND THE DRIVE SHAFT HAD BECOME DISCONNECTED FROM THE TRANSMISSION DUE TO FAILURE OF A UNIVERSAL JOINT. THE END OF THE DRIVESHAFT HAD BOUNCED OFF THE PAVEMENT AND HIT THE BOTTOM OF THE TRUCK, WHICH CAUSED THE BOTTOM PRODUCT LINE TO RUPTURE AND ALSO DESTROYED THE EMERGENCY SHUT OFF VALVE. WITH THIS AMOUNT OF DAMAGE ALL THAT COULD BE DONE WAS TO CONTAIN THE SPILL (SORBENT PADS & BOOMS, BUCKETS & TRASH BARRELS) UNTIL ANOTHER TRUCK ARRIVED TO PUMP OUT THE REMAINING PRODUCT. TO PREVENT A SIMILAR INCIDENT IN THE FUTURE STEPS ARE BEING TAKEN TO FABRICATE SOME KIND OF GUARD TO KEEP THE DRIVE SHAFT FROM STRIKING ANY CRITICAL COMPONENTS IF IT FAILS.
