UNLOADING PROCESS WAS IMMEDIATELY STOPPED AND TRAILER WAS SHUT DOWN. CLEANUP ON SITE WAS PERFORMED BY PLANT EMPLOYEES. DRIVER AND CORRY FIRE DEPT. FURTHER SOIL REMEDIATION HAS BEEN PERFORMED BY AN ENVIRONMENTAL FIRM HIRED BY FOAMEX. OCCURRENCE WAS PREVENTABLE AS DRIVER USED A HOSE WHICH IS INTENDED ONLY FOR CERTAIN PRODUCTS. IT WAS INCOMPATIBLE WITH THE PRODUCT DICHLOROMETHANE. FUTURE INCIDENTS WILL BE AVOIDED BECAUSE USE OF THE PARTICULAR HOSE HAS BEEN DISCONTINUED AT ALL UNLOAD POINTS.
