OUR DRIVER DELIVERED A LOAD TO MEMPHIS, TN. ONE OF THE SUPERVISORS AT MEMPHIS MET OUR DRIVER AT THE UNLOADING AREA AND PROCEEDED TO CHECK OUT UNIT. HE CHECKED THE SEALS ON OUR TANK AND TOLD OUR DRIVER TO UNLOAD IN THE TANK WITH THE CAP OFF. THE SUPER HOOKED UP THE GROUND WIRE WHILE OUR DRIVER WAS HOOKING UP THE UNLOADING HOSE. HE PROCEEDED TO UNLOAD AND THE SUPER LEFT THE AREA. SHORTLY THEREAFTER OUR DRIVER SMELLED GAS AND IMMEDIATELY SHUT OFF AL FLOW OF GASOLINE. HE TRACED THE SMELL AND FOUND THE TANK HE WAS UNLOADING INTO WAS OVERFLOWING. HE IMMEDIATELY NOTIFIED MEMPHIS AERO AND FIRE DEPT WAS CALLED TO THE SCENE. MEMPHIS TOOK FULL RESPONSIBILITY FOR THE OVERFLOW BECAUSE THE SUPER HAD TOLD OUR DRIVER TO UNLOAD IN THE WRONG TANK.
