Describe:

On May 15, 2014 at 1720 hours contractors in the CSXT Radnor Yard reported a release from TCIX 16130, a loaded tank car of Suflur, leaking from the bottom outlet valve. Contractor personnel had heated the car and were preparing to partially transload the contents because the tank car had been found to be overweight. The car was isolated and the shipper, Duke Energy, was notified (CHEMTREC Report #145-244). SWS Environmental, the CSXT response contractor that was already on site, replaced the secondary securement cap on the bottom outlet nozzle to stop the release. The issue identified and corrective actions were communicated to the shippers representative. Contractor personnel also mobilized materials and equipment necessary to remediate the release. The tank car is currently being held at CSXT Radnor Yard pending the shipper obtaining the necessary OTMA to allow the car to transport for unloading and subsequent home shop for bottom outlet valve repair.
