CGLX 703 - LOAD (SODIUM CHLORATE) WAS INVOLVED IN A DERAILMENT AND RECEIVED DAMAGE TO THE A-END HOPPER AT THE BOTTOM UNLOADING SLOPE SHEETS. THE HOPPER UNLOADING SLOPE SHEETS WERE IMPACTED BY THE A-END TRUCK ASSEMBLY, AXLE #3 RIGHT WHEEL PUNCTURED AND RIPPED A GASH INTO THE UNLOADING SLOPE SHEET APPROXIMATELY 18 INCHES LONG BY 6 INCHES WIDE. THE HOPPER UNLOADING SLOPE SHEETS WAS TEMPORARILY PATCHED AND THE HOPPER CAR WAS MOVED FOR TRANSLOADING. APPROXIMATELY 10,000 LBS OF PRODUCT FROM THE A-END HOPPER SPILLED AND WAS RECOVERED FOR DISPOSAL. THE CAR WILL BE CLEANED & PURGED AND SCRAPED ON SITE.
