Describe:

Driver was east bound on smith road making a left hand turn on Chambers. Left tires on the pup hit center median causing trailer to over turn on its right hand side. Pup trailer came unattached to lead trailer. Pup trailer rested on its side on train tracks. Tank gauge on pup trailer was shoved into the tank causing a one inch opening around the gauge. There was a 500 gallon loss and clean up crews were on scene immediately after the accident.
