AVAILABLE INFORMATION INDICATES DRIVER ENTERED STORE ON LEFT SIDE OF WESTERLY DRIVEWAY IN ORDER TO AVOID LEGALLY PARKED CARS IN STATION LOT. REAR TANDEM AXLE ELEVATED SLIGHTLY ON DRIVEWAY EDGE AND A COMBINATION OF TRACTION LOSS AND AIR BAG DEFLECTION CAUSED THE DELIVERY FITTING BOX TO CONTACT THE DRIVEWAY APRON, DISLODGE AND PUNCTURE SEDE OF TANK, SPILLING CONTENTS OF COMPARTMENT. FITTING BOXES OF ALL LIKE DESIGN WILL BE RETRO-FITTED WITH AFTER-MARKET BOXES THAT ALLOW AN ADDITIONAL 7" OF GROUND CLEARANCE. (4 TRAILERS)
