OUR DRIVER ARRIVED AT HIS DESTINATION, CHECKED IN WITH THE GUARD AND WAS DIRECTED TO THE UNLOADING AREA. HE WAS MET BY THE RECEIVER WHO CHECKED THE SHIPPING DOCUMENTS AND INFORMED THE DRIVER THAT THE PLANT PERSONNEL WOULD HANDLE THE UNLOADING. THE DRIVER TOLD THEM HE WOULD BE IN HIS TRACTOR DOING PAPER WORK. THE PLANT PERSONNEL PROCEEDED TO START THE DELIVERY AND A SHORT TIME LATER OUR DRIVER HEARD A WHISTLING NOISE AND EXITED HIS TRACTOR TO INVESTIGATE. THE NOISE GOT LOUDER AND WAS JOINED BY A RUMBLING SOUND AND AT THIS POINT THE TOP OF THE CUSTOMER'S STORAGE TANK BLEW OFF, SPEWING A CLOUD OF VAPOR. OUR DRIVER EXITED THE AREA ALONG WITH THE PLANT PERSONNEL. IT WAS LATER DETERMINED THAT THE PLANT PERSONNEL UNLOADED THE MATERIAL INTO THE WRONG STORAGE TANK. THE CUSTOMER ACCEPTED FULL RESPONSIBILITY FOR THE INCIDENT AND HANDLED ALL CLEAN UP. THE FIGURES ON EVACUATIONS AND INJURIES WERE OBTAINED FROM NEWSPAPER CLIPPINGS. ITEMS MARKED IN SECTIONS 41 THRU 45 REFER TO THE CUSTOMER'S STORAGE TANK AND NOT THE CARGO TANK. THE CARGO TANK DID NOT FAIL.
