PRODUCT SPILL WAS THE RESULT OF A SINGLE VEHICLE ROLLOVER ACCIDENT. AS THE CARGO TANK ROLLED OVER, AN UNLOADING PRESSURIZATION FITTING ON THE DOME LID WAS BROKEN BY CONTACT WITH GROUND ALLOWING PRODUCT TO ESCAPE. APPROXIMATELY 4480 LBS. ESCAPED BEFORE THE LEAK WAS STOPPED BY A RESPONDING HAZMAT TEAM FROM SOUTH BEND, INDIANA. REMAINDER OF PRODUCT IN THE DAMAGED CARGO TANK WAS TRANSLOADED BY COMPANY PERSONNEL INTO ANOTHER CARGO TANK. THE SPILLED PRODUCT WAS CONTAINED IN A SMALL AREA DUE TO THE AREA'S NATURAL CONTOUR AND GRADING. FOLLOWING DISCUSSIONS WITH THE STATE ENVIRONMENTAL PROTECTION AUTHORITIES AND THE MANUFACTURER OF THE PRODUCT, NEUTRALIZATION OF THE SPILL WAS ACCOMPLISHED ON SITE. NO WASTE WAS PRODUCED THAT REQUIRED OFF-SITE TRANSPORT FOR TREATMENT OR DISPOSAL.
