At 1847 ET received an update from the contractor that they have completed the required work to get the roadway opened again have grabbed the samples requested by TCEQ and are departing the scene.

On August 08, 2025, at 0812 ET the contractor is headed to site to perform excavation and remediation of the impacted area, and completed excavation and remediation of the site by 0927 ET
