VEHICLE #1 IN LANE #2 SIGNALS ON TO MAKE A RIGHT HAND TURN - PULLED INTO THE OUTSIDE OF LANE #2 PROCEEDED TO MAKE A RIGHT HAND TURN. VEHICLE #2 CAME ON THE INSIDE OF THE RIGHT HAND TURN LANE UNDERNEATH TRAILER HITTING THE UNDERNEATH CARRIAGE OF SEMI-TRAILER. GENTLEMEN IN VEHICLE #2 WALKING AROUND AFTER THE ACCIDENT - THEN AT THE SOUND OF THE POLICE ARRIVING, FELL TO THE GROUND CLAIMING INJURY. AS A RESULT OF THE ACCIDENT, HITTING THE UNDERCARRIAGE OF THE SEMI-TRAILER, THE VALVE ON THE TRAILER WAS PUNCTURED CAUSING A SPILL OF APPROXIMATELY 2500 GALLONS OF JP4 ON THE GROUND. A & M PUMPING WAS DISPATCHED TO PICK UP THE WASTE, ANOTHER TANKER TRAILER EMPTIED THE REST OF THE TANKER RETURNING PRODUCT TO DEFENSE FUEL - SAN PEDRO. COPIES OF THE PRODUCT PICKED UP AND DUMPED ENCLOSED.
