Describe:

On February 21, 2014, a Dupre Logistics truck was delivering a shipment of UN1307 liquid xylene to the unmanned Oxy Permian tank battery. Dupre Logistics was acting as the carrier for material shipped by Univar to Oxy Permian. The Dupre driver was pumping the material from the Dupre truck to an Oxy Permian tank, when the tank overflowed, releasing approximately 120 gallons of material into the concrete containment area below the tank. The containment area is approximately 10 feet by 10 feet, and the material was approximately two inches deep. Initial investigation revealed that the tank volume gauge was malfunctioning, and the gauge did not show that the tank was at capacity. The Dupre driver terminated the transfer once the overflow was noticed. No soils, storm drains or waterways were impacted by this release.

Nalco Champion, owners of the tank facility, had hired Bronco Services of Hobbs, NM to perform the clean-up and remediation.
