OUR LOGEX DRIVER HAD JUST ARRIVED AT RIVER OAKS HOSPITAL AND WENT INSIDE TO CHECK IN AND USE THE TELEPHONE. OUR DRIVER CAME OUT AFTER SEVERAL MINUTES AND FOUND LIQUID OXYGEN FLOWING FROM A LIQUID SAMPLE LINE. THE LIQUID SAMPLE LINE BROKE AT A MECHANICAL JOINT. THE STAINLESS STEEL TUBING THAT IS ATTACHED TO A LIQUID LINE AT A SWAGELOK FITTING WHICH EVENTUALLY LEADS TO THE PRESSURE BUILDING COIL BROKE. THE LINE CARRIES ABOUT 10 POUNDS OF PRESSURE. THE PRESSURE IN THE TRAILER WAS VENTED AND THE SAMPLE LINE WAS CAPPED, THE TRAILER WAS THEN OFF-LOADED WITHOUT FURTHER INCIDENT. THE TRAILER WAS TAKEN BACK TO THE SHOP AND THE SAMPLE LINE REPAIRED. THE TRAILER WAS INSPECTED THOROUGHLY AND IT WAS DETERMINED THAT THE TRAILER WAS FINE EXCEPT FOR THE BREAK IN THE STAINLESS STEEL TUBING.
