Con-way driver reported hitting a patch of ice. Thus causing his back trailer to swing and him to over-correct. While trying to correct the driver flipped both trailers and tractor and was ejected from his tractor through front windshield. All freight in both trailers fell out onto the ground due to damage to the trailers themselves. Two totes of POTASSIUM HYDROXIDE SOLUTION, 8 UN 1814 PGII R.Q. NAERG NO 154 were both damaged at time of accident and more contents of the hazardous material and other freight was lost at time of clean up.
