THE CARGO TANK WAS CARRYING 6,50 GALLON OF VYNYL ACETATE WHICH IGNITED AS A RESULT OF THE TANK OVERTURNING. SOME OF THE PRODUCT DID FLOW DOWN INTO SURROUNDING WATER BASIN, THE EXACT AMOUNT IS UNKNOWN. THE MAJORITY OF THE PRODUCT WAS BURNED OFF DURING THE FIRE ACCORDING TO THE OFFICIALS OF THE HAZARDOUS MATERIAL RESPONSE UNIT OF THE NEW JERSEY TURNPIKE AUTHORITY AND THE NEWARK FIRE DEPT. WATER BASIN MONITORING WAS PERFORMED IN OUTLYING AREAS BY THE HAZARDOUS MATERIALS UNIT OF THE TURNPIKE AUTHORITY AND BY THE N.J. D.E.P. EMERGENCY RESPONSE UNIT. WHEN THE ACCIDENT SCENE WAS CLEARED UP AND AL DEBRIS REMOVED, WATER MONITORING RESULTS WERE NEGATIVE OF ANY CONCENTRATED AREA OR HOT SPOTS, THIS ALSO INCLUDED LAND, AND SOIL. DRIVER WAS TAKEN TO HOSPITAL, TREATED AND RELEASED THE FOLLOWING DAY. POLICE REPORT AND WITNESSES SAY THE DRIVER WAS NOT SPEEDING, OUR INVESTIGATION DID NOT FIND ANY MECHANICAL DEFECTS. THE CAUSE OF THE ACCIDENT IS STILL BEING INVESTIGATED.
