APPROX 5500 GALLONS HAD BEEN DELIVERED WHEN THE RECEIVER TOLD DRIVER TO SHUT DOWN PTO PRODUCT PUMP AND HALT DELIVERY. RECEIVER HAD TOLD THE DRIVER TO CONNECT TO THE WRONG INLET. PRODUCT WAS DELIVERED INTO WRONG STORAGE TANK. THE TANK ALREADY HAD 5200 GALLONS IN IT. THIS CAUSED ABOUT 700 GALLONS OF PRODUCT TO OVERFLOW THROUGH VENT PIPE AND INTO CEMENT CONTAINMENT PIT BENEATH THE STORAGE TANK. GENERAL ELECTRIC TOOK FULL RESPONSIBILITY FOR THE ERROR. THEY HANDLED CLEAN UP OF SPILLED MATERIAL.
