Propane odor was detected by switching crew. Car was isolated and New Orleans Fire Dept. found car to be leaking from the liquid line valve. United States Environmental Services arrived and determined the leak was coming from the 2" plug on the liquid valve. The valve was closed and tightened and then the plug was removed, cleaned, reinstalled and tightened. The entire dome area was sprayed and checked for leaks. No leaks were found, the dome was closed and the car was released for movement.
