THE HOSE ON THE LOADING LINE CAME UNCONNECTED WHILE LOADING A CARGO TANK WITH SULFURIC ACID. THE OPERATOR FAILED TO NOTICE IT IMMEDIATELY AND SULFURIC ACID WAS PUMPED ONTO THE GROUND FOR SEVERAL MINUTES BEFORE THE OPERATOR REALIZED WHAT HAD HAPPENED. WHEN THE OPERATOR NOTICED IT HE SHUT OFF THE LOADING PUMP, CLOSED THE LOADING VALVE AND NOTIFIED SUPERVISION. THE COMPANY SPILL RESPONSE TEAM WAS CALLED IN TO NEUTRALIZE AND CLEAN UP THE SPILL. APPROXIMATELY 80 YARDS OF CONTAMINATED SOIL WAS REMOVED AND DISPOSED AT PINE TREE WASTE, INC., A SPECIAL WASTE LANDFILL. THE OPERATOR WAS DISCHARGED FOR INATTENTIVENESS AND IMPROPERLY CONNECTING THE LOADING HOSE.
