CSXT'S TRAIN R534-26 DERAILED 18 CARS AT TUNNEL HILL, KY. (MP=36.4). 3 TANKS OF VINYLIDENE CHLORIDE AND 1 TANK CAR OF HYDROGEN FLUORIDE WERE DERAILED ON THEIR SIDES. ON 8/27, WHILE RERAILING THE 3RD TANK CAR, IT WAS FOUND THAT GATX 24741, VINYLIDENE CHLORIDE HAD A PUNCTURE IN THE A END JUST ABOVE THE COUPLER AND HAD RELEASED ITS ENTIRE CONTENTS. VISUAL INSPECTIONS AND AIR MONITORING EQUIPMENT DID NOT DETECT THE RELEASE. CSXT'S EMERGENCY RESPONSE CONTRACTOR, OHM CORP, SURVEYED THE AREA AND FOUND THE SPILLED PRODUCTS HAD FLOWED 150 FT DOWN THE MOUNTAIN SIDE AND ALONG A STORM WATER RUN OFF CREEK BED. RECOVERY AND CLEAN UP EFFORTS WERE HAMPERED BY THE INACCESSIBLE TERRAIN. THE HYDROGEN FLUORIDE CAR WAS MOVED TO THE CONSIGNEE'S FACILITY FOR UNLOADING AND THE REMAINING 2 VINYLIDENE CHLORIDE CARS WERE TRANSLOADED AT LOUISVILLE, KY ON 9/9/93.
