Describe:

Newman Transport driver was delivering Diesel into a above ground storage tank at the site. He hooked up his hose to the 2000-gallon side instead of the 10,000-gallon side of a split 12,000-gallon tank. The 2000 gallons tank had approx. 1200 gallons in it and the tank on truck had 2400 gallons. Once pumping off the driver did not notice the overfill for approximately 3 minutes even though he was standing on side of the trailer. When he noticed the spill, he shut down pump process. Called dispatch to report spill and began containing spill. Pearl River Fire department was called and arrived on scene. LA State Police were notified and trooper showed up also. Report #25-03706.

E3 Environmental was called at 14:44 and were on site at 15:25. All product was recovered by vac-truck, absorbent pads and floor-dry and disposed of by E3.
