TANK CAR CONTAINING A 40% FERRIC CHLORIDE SOLUTION, WAS DISCOVERED LEAKING ON NO.56 TRACK IN THE YARD IN HAMLET, NC. THE CAR WAS LEAKING A ONE INCH STREAM FROM THE BOTTOM OF THE CAR. APPARENTLY, THE RUBBER LINING IN THE CAR FAILED ALLOWING THE PRODUCT TO CORRODE AND DETERIORATE THE STEEL TANK. THE CAR WAS ISOLATED ON THE OLD CHIP MILL TRACK. A DIKE WAS CONSTRUCTED AROUND THE CAR AND A PIT WAS DUG AND LINED WITH PLASTIC TO CONTAIN THE LEAKAGE. APPROX 12,500 GALLONS WRE PUMPED FROM THE CAR AND 2,700 GALLONS WRE RECOVERED FROM THE LINED PIT. THE RESIDUE REMAINING IN THE SOIL WAS NEUTRALIZED WITH LIME KILN DUST.
