WHILE APPROACHING 40' CURTAIN VAN TRAILER AT AN ANGLE, JIM MURRAY HIT A DIP IN THE ASPHALT. THE TOTE OF TOUGH FOAM BEING TRANSPORTED ON THE FORK LIFT FELL FORWARD. JIM COULD NOT DROP THE FORKS QUICKLY ENOUGH TO PREVENT THE TOTE FROM TIPPING. IMPACT OF TIPPING CAUSED TOP OF TOTE TO FRACTURE/BLOW OUT. TOUGH FOAM IN THE TOTE SPILLED ON ASPHALT, IN A NATURAL DEPRESSION. THE ENTIRE AREA WAS RINSED CLEAN, PUMPED TO A STORAGE TANK, AND RELEASED TO THE NAMPA WASTEWATER FACILITY.
