THE TRUCK WAS NORTH BOUND ON HWY 61 BETWEEN FAYETTE AND REDWOOD, MS. TRUCK RAN OFF ROAD TO RIGHT, SERVE BACK ONTO HWY 61 AND ROLLED TRUCK. TRUCK SLID ON PAVEMENT BREAKING 3/4" AIRLINE. TRUCK HIT TREE CAUSING TRUCK TO FLIP 180 ON HWY RIGHT OF WAY WITH DOME LIP AT 8 O'CLOCK DOWN. SPILLAGE WAS CONTAINED IN SMALL CONCRETE DITCH FLOWING TOWARD NORTH FORK COLD CREEK. LIME WAS USED IN DITCH TO NEUTRALIZE ACID. THERE WAS NO ACID THAT REACHED NORTH FORK COLD CREEK. P.H. MONITORING WAS DONE AT MOUTH OF NORTH FORK, READING STAYED NEUTRAL. BIOLOGIST CRECK DITCH AND CREEK AREA, FOUND NO ENVIRONMENTAL DAMAGE. DISCUSS DANGERS OF TRYING TO BRING TRUCK BACK ONTO HIGHWAY ONCE DRIFTING OFF ROADWAY DURING QUARTERLY SAFETY MEETING.
