THE CUSTOMER TOOK RESPONSIBILITY FOR THE SPILL AND THE CUSTOMER PERFORMED THE CLEAN UP. THE PRODUCT WAS CONTAINED TO THE CONTAINMENT AREA AROUND THE OFF-LOADING PIT.
