Describe:

At approximately 08:00 on November 2, 2017, a quad axel truck spilled approximately 1000 to 1500 pounds of RCRA hazardous waste solids on the exit pad of the facility's scale.

Facility personnel responded to the spill by building a gravel berm around the affected area. The spilled material was recovered. An affected area of gravel service road exiting the scale was excavated to an approximate depth of six (6) inches. The recovered material and excavated gravel were transported to the active working face of the landfill, off loaded, and buried following the facility's receiving and unloading procedures. The concrete was pressure washed and the liquids recovered; approximately 85-gallons. The recovered liquid was placed in the facility's leachate collection tank which is managed as a 90-day generator tank for F039 leachate.

Describe:

The incident investigation determined the cause as human error by the driver. The driver failed to fully tighten the tailgate turnbuckles. The truck crossed the speedbump exiting the facility's scale causing the tailgate to jar open. The employee received a written reprimand with document consequences of any future failure to follow established operating procedures.
