OUR DRIVER WAS SHOWN WHERE TO HOOK UP THE DISCHARGE HOSE TO CUSTOMER'S TANK AND GIVEN THE APPROVAL TO BEGIN UNLOADING THE CARGO TANK. DURING THE UNLOADING PROCESS OUR DRIVER WAS TOLD THAT PRODUCT (SULFURIC ACID) WAS RUNNING OUT OF ANOTHER LINE FROM THIS STORAGE TANK DUE TO THE CUSTOMER'S TANK DRAIN OFF VALVE WASN'T PROPERLY CLOSED. THIS ALLOWED PRODUCT TO DRAIN OUT OF STORAGE TANK INTO A SELF CONTAINED DIKE.
