THE LABORER WAS IN THE ACT OF TRANSFERRING A SULFURIC ACID WHEN THE PRODUCT HOSE RUPTURED OVER THE TOP OF THE TANKCAR. THE HOSE WAS INSPECTED PRIOR TO THE TRANSFER AND IT SHOWED NO SIGN OF DEFORMATION. THE RUPTURE OF THE HOSE ALLOWED THE RELEASE OF 175 GALLONS OF BEFORE THE FLOW COULD BE STOPPED. THE HOSE IS CURRENTLY BEING EXAMINED BY THE MANUFACTURER FOR DEFECTS.
