DRIVER CARRYING PLACARDABLE QUANTITY OF HAZARDOUS MATERIAL REQUIRING THE USE OF US6 INSTEAD OF PASSING THROUGH THE ISENHOWER TUNNEL ON INTERSTATE 70. DRIVER TOOK 110 DEGREE TURN AT 25MPH IN POSTED 20MPH. LEAD TRAILER AND TRACTOR OVERTURNED CAUSING SPILL OF 400 GALLONS OF NON HAZARDOUS CEMENT & CONCRETE COLORING DYE FROM ROCKWOOD PIGMENTS 3701 EAST UNION PACIFIC AVE. LOS ANGELES, CA 90023. ONE 400 GALLON PLASTIC TOTE LID POPPED OFF RELEASING 400 GALLONS. THE 400 GALLON NON HAZARDOUS MATERIAL WAS RELEASED INTO A STREAM LEADING TO THE DILLON RESERVOIR. HAZMAT ONE EMERGENCY RESPONSE WORKED WITH LOCAL AND STATE AGENCIES TO CLEAN THE CONTAMINATED EARTH AND TEST THE STREAM FOR CONTAMINATION. CLEANUP IS COMPLETE, BUT TESTING WILL CONTINUE. AT THIS TIME IT DOES NOT APPEAR TO HAVE HARMED FISH OR FOUL OR TO HAVE PERMANENTLY DISCOLORED THE STREAM.
